The Trunk Road (Dolgellau, Gwynedd) (Prohibition of Right-hand Turn) Order 1979

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 1 of the Road Traffic Regulations Act 1967, the effect of which will be to prohibit any person from causing any vehicle proceeding in the west-bound carriageway of that length of the Cardiff/Glan Conwy Trunk Road (A470) known as the Dolgellau By-pass, at Dolgellau in the County of Gwynedd, from making a turn through the gening the central reservation situated at a point

Dolgellau in the County of Gwynedd, from making a turn through the gap in the central reservation situated at a point 345 yards south-east of the junction of the said Trunk Road with the new length of the Dolgellau/Tywyn Road (A493). A copy of the proposed Order, together with a plan and statement of reasons for making the Order, may be seen during normal office hours at the offices of the Meirionnydd District Council, Penarlag, Dolgellau.

Objections to the proposed Order should be sent to the Secretary of State, Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL not later than 25 February 1980 quoting the reference number WR15/4/89, stating the grounds for objection.

This proposal is identical with the one advertised on 28 September 1979.

And it is ordered that the Applicant Howcan Finance Limited do pay to the Registrar of Companies his costs of the said application such costs to be taxed on a party and party basis if not agreed.
