

3. Uniting the benefices of Saint Helen, Bishopsgate, with Saint Martin, Outwich; and Saint Andrew Under-shaft with Saint Mary Axe, in the diocese of London.

4. Uniting the benefices and parishes of Saint John the Evangelist, Southbourne; and West Thorney, in the diocese of Chichester.

5. Vesting a further part of the churchyard of the parish church of the parish of East Ham with Saint Alban, Upton Park, in the diocese of Chelmsford, in the Chelmsford Diocesan Board of Finance Limited for disposal.

6. Establishing a team ministry for the area of the benefice of Saint Wilfred, Haywards Heath; and a group ministry for the benefices of Saint Wilfred, Haywards Heath; and Saint Richard, Haywards Heath, in the diocese of Chichester.

7. Declaring redundant the church of Saint John the Baptist, Inglesham, a chapel of ease in the parish of Highworth with Sevenhampton and Inglesham, in the diocese of Bristol.

8. Appropriating part of the churchyard of the parish church of the parish of Bramley, in the diocese of Ripon, to use as a road and a car park and vesting the said land in the Ripon Diocesan Board of Finance for disposal.

9. Uniting the benefices and parishes of Lanercost with Kirkcambeck; and Walton, in the diocese of Carlisle.

10. Uniting the parishes of Kingsthorpe; and Saint David, Northampton, in the diocese of Peterborough.

11. (1) Dissolving the benefice of Holy Trinity, Croydon;
- (2) declaring redundant the parish church of the parish of Holy Trinity, Croydon;
- (3) altering the name of the benefice and parish of Saint Saviour, Croydon; and
- (4) altering the areas of the parishes of Saint Saviour, Croydon; Holy Innocents, South Norwood; Saint Alban, South Norwood, and Holy Trinity, Croydon, in the diocese of Canterbury.

12. Uniting the benefices of Claxby with Normanby; North Willingham; Stainton-le-Vale with Kirmond-le-Mire; Tealby; and Walesby, in the diocese of Lincoln.

13. Creating a new benefice of Burston, and uniting the benefices of Dickleburgh with Thelveton and Frenze; and Burston with Shimpling, in the diocese of Norwich.

14. Appropriating part of the churchyard of the parish church of the parish of Saint John, Bowling, in the diocese of Bradford, for parochial purposes, and vesting the said land in the Bradford Diocesan Board of Finance.

15. Uniting the benefices of Fiskerton and Reepham, in the diocese of Lincoln.

16. (1) Uniting the benefices and parishes of Chesham and Christ Church, Chesham;
- (2) establishing a team ministry for the area of the new benefice of Great Chesham;
- (3) transferring the parish of Saint John the Evangelist, Ashley Green, to the new benefice of Great Chesham; and
- (4) dissolving the benefice of Saint John the Evangelist, Ashley Green, in the diocese of Oxford.

17. Uniting the benefices of Sibsey with Frithville; and New Bolingbroke with Carrington; and effecting a transfer of a share in the patronage of the benefice of Corringham, in the diocese of Lincoln.

18. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant church of Saint Mary, Rickingham Superior, a former chapel of ease in the parish of Rickingham Inferior with Rickingham Superior, in the diocese of Saint Edmundsbury and Ipswich.

19. Amending an earlier Scheme and providing for the appropriation of the redundant church known as All Saints, Witham, in the diocese of Chelmsford, and part of the land annexed or belonging thereto, to use as a youth club, for other community purposes and for purposes ancillary thereto.

20. Appropriating the redundant church of Saint Catherine, Haydon, a former chapel of ease in the parish of Folke, North Wootton and Haydon, in the diocese of Salisbury, to use as a craft workshop and for purposes ancillary thereto, and empowering the said Commissioners to sell the said buildings for such uses.

21. Revoking the provisions of an earlier Scheme and providing for the appropriation of the redundant church of

Saint Oswald, Fulford, in the diocese of York, and the land annexed or belonging thereto, to use for residential purposes and for purposes ancillary thereto, and empowering the said Commissioners to sell the said building and land for such uses.

22. (1) Appropriating the redundant parish church of the parish of Holy Trinity, Halifax, in the diocese of Wakefield, to use as a restaurant and conference centre and for purposes ancillary thereto;

(2) appropriating the land annexed or belonging to the said church for purposes ancillary to the said use and for residential purposes; and

(3) empowering the said Commissioners to sell the said building and land for such uses.

23. Appropriating the redundant parish church of the former parish of Caldecote, in the diocese of Saint Albans, and the land annexed or belonging thereto, to use as a shrine or monument or for Christian community purposes ancillary thereto; and empowering the said Commissioners to give the said building and land for such uses.

### TENDERS FOR TREASURY BILLS

The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Registrar's Office (Bank Buildings) at the Bank of England on Friday, 28th March 1980 at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £300,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000, or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday, 31st March 1980 to Thursday, 3rd April 1980 inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.
