The Bassetlaw District Council (Off-Street Parking) (Chapelgate, Retford) Order 1980

Notice is hereby given that the Bassetlaw District Council have on 24th April 1980 made the above Order, which on the Chapelgate Car Park, Retford, increases the penalty payable for failing to display a valid car park ticket from £2 to £5 and which increases the charges for short stay car parking from 5p to 10p. The increase in charges and the new penalty will take effect on 1st May 1980.

A copy of the above Order, together with a map of the Car Park, can be inspected at Amcott House, Grove Street, Retford, Nottinghamshire, during normal office hours.

Any person who desires to question the validity of the above Order or of any provision contained in the said Order on the ground that it is not within the powers of section 28 of the Road Traffic Regulation Act 1967 or on the ground that any requirement of that section or of section 84A, 84B or 84C of the said Act or any regulations made under the said section 84C has not been complied with in relation to the said Order may, within 6 weeks from 24th April 1980, make application for the purpose to the High Court.
