

The effect of the Order, if confirmed without modifications, will be to extinguish the public right of way running from a point at the boundary of Field O.S. 1815 and A133 in a southerly direction for a distance of approximately 150 metres and then in an easterly direction for a distance of approximately 310 metres to Footpath No. 5 Frating on the northern boundary of Frating Lodge.

A copy of the Order and the map contained therein has been deposited and may be inspected free of charge at the Council Offices, Weeley, Clacton-on-Sea, Essex, during normal office hours.

Any representation or objection with respect to the Order may be sent in writing to the Secretary and Legal Officer, Council Offices, Weeley, Clacton-on-Sea, Essex, before 30th June 1980 and should state the grounds on which it is made.
