

Long Street to its junction with St. John's Court, then to a point parallel with the north-western boundary of the Town Hall.

The direction of travel will be from Long Street to St. John's Court thence north-westwards.

Any person aggrieved by the Order and desiring to question the validity of the Order or of any provision contained in the Order on the grounds that it is not within the powers of the relevant section of the above Act, or on the grounds than any requirement of the section or of section 84A, 84B or 84C of the Act or any regulation made under the said section 84C has not been complied with in relation to the Order, may within 6 weeks of the date on which the Order was made make application for the purpose to the High Court.

The Order will be operative as from 30th June 1980.

##### *The Council of the County of North Yorkshire (Great Heck) (Prohibition of Commercial Vehicles of Over 3 Tons Unladen Weight) Order 1980.*
