

(iii) to stop up private means of access to premises, and

(iv) to provide a new means of access to premises, all at Plas-y-Bwlch, Llangurig, aforesaid and

(b) to provide the transfer of the said new highway to the County Council of Powys as from the date on which he notifies the Council that the new highway has been completed and is open to pedestrians.
