London Borough of Haringey (Carbuncle Passageway N.17) (Part) Public Path Extinguishment Order 1979

Notice is hereby given that the above-named Order made on 14th December 1979, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the London Borough of Haringey.

The effect of the Order, if confirmed without modifications, will be to extinguish the public right of way running from Carbuncle Passageway N.17 at a point approximately 4 yards west of its junction with Shelbourne Road, N.17 to a point approximately 5 yards west of its junction with Shelbourne Road, N.17 so that access to or from Shelbourne Road, N.17 will no longer be possible.

Copies of the Order and the map contained in it have been deposited and may be inspected free of charge at the Civic Centre, Wood Green, London N22 4LE, or the Legal Division, 35 Station Road, N22 6UX during normal office hours.

If no representations or objections are duly made, or if any so made are withdrawn, the London Borough of Haringey may instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn, will be transmitted with the Order.

South Norfolk District Council (Brockdish No. 1.) Public Path Diversion Order 1980

Notice is hereby given that on 1st August 1980, the South Norfolk District Council confirmed the above Order. The effect of the Order as confirmed is to divert that part of footpath 15 running north from the footbridge over the River Waveney on the southern boundary of O.S. 5113 which then runs in a north-easterly direction through O.S. 5121, O.S. 7036 and O.S. 7747 to a line running along and inside the south-western boundary of O.S. 5113 and 3119, turning to run in a north-easterly direction along the south-eastern boundary of O.S. 2826 and 3126 then running along and inside the southern boundary of O.S. 3339, running north-westerly then generally north-easterly inside the boundary of O.S. 5544 to its previous junction.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected, free of charge, at South Norfolk House, Swan Lane, Long Stratton, between 8.45 a.m. and 4.15 p.m. on Mondays to Fridays.

The Order becomes operative as from 15th August 1980, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any Regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 6th August 1980, make an application for the purpose to the High Court.
