NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT 1971

*The Kirklees (Footpath No. 46, Shillbank View, Mirfield)
Public Path Diversion Order 1980*

Notice is hereby given that on 24th July 1980 the Kirklees Metropolitan Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way on land situate at Shillbank View, Mirfield, commencing at point "A" on the plan attached to the Order being a point on Public Footpath No. 46 for a distance of 40 metres or thereabouts in a south-easterly direction to point "B" being its junction with Public Footpath No. 47, Mirfield. The diverted path will run from point "A" described above for a distance of 7 metres or thereabouts in a south-westerly direction to point "C" on the plan then for a distance of 40 metres or thereabouts in a south-easterly direction to point "D" on the plan being a point on Public Footpath No. 47, Mirfield.

A copy of the confirmed Order and the map contained in it has been deposited at the Council Offices, Huddersfield Road, Mirfield, and may be inspected free of charge during normal office hours.

This Order becomes operative as from 8th August 1980, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order he may within 6 weeks from the date of publication of this notice make application to the High Court for the purpose.

NOTICE OF CONFIRMATION OF PUBLIC FOOTPATH DIVERSION
ORDER

TOWN AND COUNTRY PLANNING ACT 1971—SECTION 210

*The Leominster District Council (The Rugg, Leominster)
Public Path Diversion Order 1980*

Notice is hereby given that on 31st July 1980 the Leominster District Council confirmed the above Order.

The effect of the Order, as confirmed, is to divert two lengths of footpath one of which being part of the existing public footpath numbered 156 on the Definitive Map commences at a point 130 feet or thereabouts north-east of the south-west corner of Parcel No. 85 23 National Grid Sheet SO4859 and runs therefrom in a north-easterly direction for a distance of 185 feet or thereabouts and thence in a north-westerly direction for a distance of 305 feet or thereabouts and thence in a north-easterly direction for a distance of 330 feet or thereabouts to its junction with the existing public footpath numbered 6 on the Definitive Map. This length of footpath is diverted to a new line commencing at a point 130 feet or thereabouts north-east of the south-west corner of the said Parcel No. 85 23 and running therefrom in a generally northerly direction for a distance of 360 feet or thereabouts and then generally in a north-easterly direction for a distance of 470 feet or thereabouts to join the existing public footpath numbered 6 on the Definitive Map along the line marked A-B, B-C on the map annexed to the Order.

The other length of diverted footpath is part of the existing public footpath numbered 6 on the Definitive Map and situate at Leominster in the County of Hereford and Worcester commencing at its junction with the existing public footpath numbered 7 on the Definitive Map and running therefrom in a north-westerly direction for a distance of 330 feet or thereabouts to its junction with the existing public footpath numbered 156 on the Definitive Map.

This length of footpath is diverted to a new line commencing at a point on the existing public footpath numbered 7 on the Definitive Map approximately 60 feet north of the existing junction of the public footpaths numbered 6 and 7 on the Definitive Map and running therefrom in a westerly direction for a distance of 100 feet or thereabouts and thence in a north-westerly direction for a distance of 160

feet or thereabouts and thence in a westerly direction for a distance of 120 feet or thereabouts to join the existing footpath numbered 6 on the Definitive Map along the line marked D-E, E-F on the map annexed to the Order.

A copy of the Order as confirmed and the map contained in it has been deposited at the offices of the Council at M.E.B. Buildings, West Street, Leominster, and may be inspected free of charge between the hours of 8.30 a.m. and 4.30 p.m. on normal working days.

The Order becomes operative as from 31st July 1980, but if a person aggrieved by the Order wishes to question the validity thereof or any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971 or on the grounds that any requirements of that Act as amended or any Regulation made thereunder has not been complied with in relation to the confirmation of the Order he may, under section 244 of the Town and Country Planning Act 1971, within 6 weeks from 6th August 1980, make an application for the purpose to the High Court.
