## NOTICE OF PROPOSAL TO MODIFY PUBLIC PATH ORDER

## HIGHWAYS ACT 1959, SECTION 111

*Borough of Reigate & Banstead (Public Footpath No. 15A Chucks Meadow, Banstead (Part)) Public Path Diversion Order 1979.*

Notice is hereby given, pursuant to paragraph 2 (3) of the Seventh Schedule to the Highways Act 1959 that the Secretary of State for the Environment proposes to modify the Borough of Reigate and Banstead (Public Footpath No. 15A Chucks Meadow, Banstead (Part)) Public Path Diversion Order 1979 by providing that the path proposed to be diverted shall have a width of 1.8 metres.

A copy of the Order and map as submitted and a copy of the Order showing the proposed modification in red ink, have been deposited at the Information Offices at the Town Hall, Reigate and at the Council House, Brighton Road, Banstead, and may be inspected free of charge between 8.45 a.m. and 4.45 p.m. on Mondays to Fridays inclusive.

## DEPARTMENT OF TRANSPORT

## TOWN AND COUNTRY PLANNING ACT 1971

The Minister of Transport hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping up of Fearon Street and a part width of Chapel Street, Bigrigg, Cumbria, to enable residential development to be carried out in accordance with planning permission granted by Copeland Borough Council under Part III of the said Act. The proposed Order will require the improvement by widening of Chapel Street and the provision of a new footpath maintainable at the public expense, for which the highway authority is to be the County Council of Cumbria.
