### CUSTOMS AND EXCISE

#### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To: Mr. D. E. Inglesant, 108 Chester Avenue, Poulton Le Fylde, Blackpool, Lancs.

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979, and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that certain goods, namely:

Four Pieces of Ivory, imported at Manchester Airport on 23rd August 1979 have been seized on the grounds that they were imported in contravention of the prohibition imposed by section 1 of the Endangered Species (Import and Export) Act 1976, as amended, and are liable to forfeiture under section 49 (1) (b) of the Customs and Excise Management Act 1979.

If you claim that the said goods are not liable to forfeiture, you must within one month from the date of this notice of seizure give notice of your claim in accordance with paragraph 3 of Schedule 3 to the Customs and Excise Management Act 1979. If you make such a claim within that time, legal proceedings will be taken for the

condemnation of the goods. If no such claim is made, the goods will be deemed to have been duly condemned as forfeited.
