FENDEL CO. LIMITED (DISSOLVED)

*Notice of Disclaimer Under Section 355
of the Companies Act 1948*

Whereas:

(1) Pursuant to section 353 (5) of the Companies Act 1948 FenDEL Co. Limited (hereinafter called "the Company") became dissolved on the 12th September 1972.
