CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To: Whom it may concern.

2nd October 1980

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979, and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely the goods specified in Schedules 1 and 2 hereto have been seized as liable to forfeiture upon the grounds that:

- The said goods were imported into the United Kingdom on 11th June 1980 at the Jet Ferry Terminal in the Port of London by one Jan Louis Kuhn who was entering the United Kingdom.
- 3. The goods specified in Schedule 1 hereto were charge-
- able with a duty of Customs by virtue of sections 1 and 2 (3) of the Finance Act 1972.
 The goods specified in Schedule 2 hereto were packed with the goods specified in Schedule 1 hereto which were liable to forfeiture.

Whereby and by force of sections 78 (4) and 141 (1) (b) of the Customs and Excise Management Act 1979 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accord-ance with the said Schedule to the said Act. In default ance with the said Schedule to the said Act. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
