DEPARTMENT OF TRANSPORT

TOWN AND COUNTRY PLANNING ACT 1971

The Minister of Transport hereby gives notice that on the application of The Borough of Blyth Valley Council, he proposes to make an Order under section 212 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on a length of School Lane at Cramlington Village as part of the overall environmental improvement to Cramlington Village Square.

The proposed Order will contain provisions for permitting the use of that highway by vehicles being used:

- For police, ambulance or fire brigade purposes;
- On behalf of a statutory undertaker or the Post Office and engaged upon the laying, erection, inspection, maintenance, alteration, repair, renewal or removal of any main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water or electricity or any telegraphic line as defined in the Telegraph Act 1878, under, in, on, over, along or across the highway or any land adjacent to the highway;
- On behalf of a water authority and engaged upon the laying, inspection, maintenance, alteration, repair, renewal or removal of any public sewer under, in, on, over, along or across the highway or any land adjacent to the highway;
- Where the vehicle is a pedal cycle, being a bicycle or tricycle which is not mechanically propelled.

During 28 days from 2nd October 1980 copies of the draft Order and relevant plan may be inspected at the offices of the Regional Controller (Roads and Transportation), Northern Region, Wellbar House, Gallowgate, Newcastle-upon-Tyne NE1 4TX, and at the address of the County Planning Department, Civic Precinct, Forum Way, Cramlington New Town, and may be obtained free of charge from the Minister (quoting Ref. DN 506835/10), at the address stated below.
