# RATES OF INTEREST ON LOANS BY THE PUBLIC WORKS LOAN COMMISSIONERS TO LOCAL **AUTHORITIES**

The Treasury hereby give notice that in accordance with the powers conferred upon them by the National Loans Act 1968 (1968 c. 13) on or after 4th October 1980:

- I. Town and Country Planning Act 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under section 212 of the Town and Country Planning Act 1971 to extinguish any rights which persons may have to use vehicles on the length of road specified in the Schedule to this Notice.

The Order contains provisions for permitting the use of that highway by vehicles being used:

(a) for police, ambulance or fire brigade purposes;

(b) on behalf of a statutory undertaker, a water authority or the Post Office and engaged on the maintenance of their apparatus;

(c) in accordance with the special authorisation for that use given by or on behalf of the County Council of Dyfed, the Borough Council of Llanelli or the Chief

Officer of Police for that area; or

(d) where the vehicle is an invalid carriage (mechanically electrically or hand propelled), or a vehicle which has been issued to a disabled person by the Government

in lieu of an invalid carriage.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting Ref. WR15/24/3), and may be inspected at all reasonable hours at the offices of the Llanelli Borough Council, Town Hall, Llanelli.

Any person aggrieved by the Order and desiring to question the validity thereof, of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 30th October 1980 apply to the High Court for the suspension or quashing of the Order or of any provision contained

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to the highway to which the Order relates shall be entitled to be compensated by the Llanelli Borough Council as the local planning authority in respect of any depreciation in the value of his interests which is directly attributable to the Order and of any other loss or damage which is so attributable.

Description of the highway to which this Notice relates. The highway is situated at Llanelli in the County of Dyfed and is that length of Market Street (B4304) which extends from the northern side of its junction with Park Street (B4305) in a north-westerly direction for a distance of approximately 50 yards. The Trunk Road (Penparcau, Aberystwyth) (Prohibition of Waiting) Order 1980

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, which shall come into operation on 23rd October 1980. The effect of the Order will be to prohibit the waiting of any vehicle at any time on the side of road specified in the Schedule to this

Exceptions in the Order will permit waiting for the following purposes:

(a) picking up or setting down passengers;
(b) loading or unloading goods;
(c) building, industrial or demolition operations; and
(d) carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.

The usual exceptions have also been provided in the Order for vehicles displaying a disabled person's badge.
