MID GLAMORGAN COUNTY COUNCIL

TOWN AND COUNTRY AMENITIES ACT 1974

Notice is hereby given that the Mid Glamorgan County Council as the County Planning Authority have cancelled the designation of Cwmpennar, Mountain Ash, as a conservation area pursuant to section 277 of the Town and Country Planning Act 1971.

Consequently, those provisions of the Town and Country Amenities Act 1974, which bring the demolition of most buildings in conservation areas under local authority control by applying with modifications the listed building control powers under the Town and Country Planning Act 1971 shall no longer apply.
