### NEW TOWNS ACT 1965

#### EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY

*The New Town of Peterborough, Orton Waterville, Peterborough*

Notice is hereby given that the Secretary of State for the Environment, in exercise of his powers under section 23 of the New Towns Act 1965, has made an Order extinguishing the public rights of way over the following footpath and bridleway shown by bold broken black lines on the map hereinafter referred to:

- (a) That part of Bridleway BR 10 from a point, marked "A" on the map, on the northern boundary of the Village Hall, Glebe Avenue, Orton Waterville, extending in a northerly direction for a distance of approximately 300 metres, and then in a north-westerly direction for a distance of approximately 70 metres to a point marked "B" on the map.
- (b) That part of Footpath FP 7A from the junction of the footpath and Orton Parkway approximately 200 metres south of the Oundle Road, which point is marked "C" on the map, and extending eastwards for a distance of approximately 135 metres, then southwards for a further distance of approximately 80 metres, then eastwards for a distance of approximately 575 metres to a point marked "D" on the map, at its junction with Bridleway BR 10.

The Order is dated 30th September 1980, and a copy of it and of the map referred to in it showing the rights of way which have been extinguished may be inspected at the offices of the Peterborough Development Corporation, Touthill Close, Peterborough, during normal office hours.

### TOWN AND COUNTRY PLANNING ACT 1971
