HIGHWAYS ACT 1959 TO 1971

The County of South Glamorgan (Cardiff Central Distributor Road—Phase III Classified Road) (Side Roads) Order 1980

The Secretary of State for Wales hereby gives notice that he has confirmed the above Order which was made by the County Council of South Glamorgan under sections 1 and 62 of the Highways Act 1971 and which, as confirmed, provided for authorising the Council:

(a) to improve, raise, lower or otherwise alter highways, and (b) to stop up a highway.

All on or in the vicinity of the route of the classified road which the Council are proposing to construct between Fitzalan

Place and Adam Street, Cardiff.

HIGHWAYS ACTS 1959 TO 1971

The Trunk Road (Leeds Ring Road and Station Road (A6120) Crossgates) (Restriction of Waiting) (Variation) Order 1980

The Minister of Transport hereby gives notice that he has made an Order under sections 1 and 84D of the Road Traffic Regulations Act 1967, as amended by part IX of the Transport Act 1968, on the Liverpool—Leeds—Hull Trunk Road (A6120) at Crossgates in the Leeds Metropolitan District in the county of West Yorkshire.

The effect of the Order which comes into operation on 23rd October 1980, is to extend the exemptions in the existing Order

by allowing:

(a) disabled persons' vehicles to park on all lengths of road included in the Order other than between 4.30 p.m. and

6.30 p.m. on the west side of Station Road;
(b) emergency vehicles to wait at any time.
The detailed modifications to the Order are set out in the Schedule to this notice.

Any person who desires to question the validity of the Order or any provision contained therein on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of
