Notice is hereby given that the above-named Orders made on 3rd October 1980 are about to be submitted to the Secretary of State for the Environment for confirmation or as the case may be confirmed as unopposed Orders by the Cumbria County Council.

The effect of the Orders if confirmed without modification will be to extinguish the public right of way:

- (1) Over parts of footpaths Nos. 361008 in the Parish of Shap Rural and 306003 in the Parish of Bampton, both in the vicinity of Bowderthwaite Bridge and the whole of footpath No. 306002 in the Parishes of Bampton and Martindale leading over Kidsty Pike, and to create new footpaths following the same general alignments but avoiding difficult or dangerous sections.
- (2) Over that part of footpath No. 220013 in the Parish of Buttermere running from south of Bleak Rigg generally north-eastwards for approximately 2,410 metres along the line of Sail Beck to a point approximately 200 metres south-west of Rigg Beck. (The right of way between these points will still be provided by footpath No. 220045 which runs approximately 200 metres to the north-west on the same route).
- (3) Over that part of footpath No. 407031 in the Parish of Ennerdale and Kinniside from a point approximately 200 metres south of Scarth Gap generally westwards and south-westwards for approximately 1,090 metres to its junction with bridleway No. 407021. (The right of way will still be provided by footpath No. 407052 which runs approximately 100 metres to the south on the same route).
- (4) Over the whole of footpath No. 408081 in the Parish of Eskdale from a point approximately 200 metres east of Cowcove Beck running generally northwards to a point approximately 400 metres south of Sampson's Stones and a 270 metre length of footpath No. 408042 extending south-eastwards from its junction with footpath No. 408011 south-west of Sampson's Stones. (The right of way between these points will still be provided by footpath No. 408011 running on approximately the same alignments).
- (5) Over that part of footpath No. 408011 in the Parish of Eskdale from a point approximately 200 metres east of Cowcove Beck running generally northwards to a point approximately 200 metres north of Sampson's Stones and to create a new footpath running between the same points but passing just east of Silveryield Crag.
- (6) Over a 300 metre stretch of footpath No. 408032 in the Parish of Eskdale curving north-eastwards then northwards from near Throstle Garth over the rocks of Throstlehow Crag. (The right of way will still be provided by footpath No. 408075 running along the western foot of Throstlehow Crag).
- (7) Over 1,525 metres of footpath No. 408032 in the Parish of Eskdale from the junction of Little Narrow Cove and the Esk running north-north-eastwards to Esk Hause. (The right of way will still be provided by footpath No. 408076 running on the same general line but following the west bank of the Esk).
- (8) Over 1,200 metres of footpath No. 408050 in the Parish of Eskdale from its junction with footpath No. 408053 running north-eastwards to Great End. (The right of way will still be provided by footpaths Nos. 408052 and 408077 running between the same points approximately 200 metres to the east).
- (9) Over footpath No. 408049 in the Parish of Eskdale from its junction with bridleway No. 408015 beside Burnmoor Tarn running north-eastwards then east-north-eastwards to near Sca Fell summit. (The right of way between these points will still be provided by footpath No. 408079 running in the same direction approximately 100 metres to the south-east).
- (10) Over 2,420 metres of footpath No. 408043 in the Parish of Eskdale from its junction with footpath No. 408080 south of Goat Crag northwards then north-westwards to its junction with footpath No. 408044 north of Cat Cove and over 2,860 metres of footpath No. 408044 from a point due west of High Scarth Crag over Slight Side to near Sca Fell summit. (The right of way between these points will still be provided by footpath No. 408080 running close to the same alignment.)
- (11) Over 3,750 metres of footpath No. 408080 in the Parish of Eskdale from its junction with footpath No. 408043 south of Goat Crag northwards to the top of Slight side and to create a new right of way over the same general alignment but avoiding difficult or dangerous sections.
- (12) Over 1,020 metres of footpath No. 408051 in the Parish of Eskdale from its junction with footpath No. 408078 south-west of Round Howe running north-eastwards to the Parish boundary and continuing as
