2. The effect of the Order will be:

- (a) to prohibit vehicles the overall width of which together with the load (if any) carried thereon exceeds 7 feet from entering that length of St. Mark's Road which lies between a point 8.52 metres west of the western kerb-line of Armfield Crescent and a point 7 metres west of that kerb-line, measured on the north side:
- (b) to impose one-way working for vehicular traffic from west to east in St. Mark's Road between a point 8.52 metres west of the western kerb-line of Armfield Crescent and that kerb-line,
- 3. The prohibition referred to in paragraph 2 (a) above will not apply in relation to vehicles being used for ambulance, fire brigade or police purposes in certain circum-
- 4. The prohibition and requirement referred to in paragraph 2 above will not apply in respect of anything done:
  - (a) with the permission or at the direction of a police constable in uniform
  - (b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.
- 5. The Order provides that in pursuance of section 9 (5) of the Road Traffic Regulation Act 1967, the Chief Engineer of the Council's Department of Planning and Transportation, or some person authorised in that behalf by him, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the ment of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs, modify or suspend the Order or any provision thereof.

If the provisions of the Order continue in operation for a period of not less than 6 months, the Council will consider in due course whether the provisions of the Order should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1967. (a) the Croydon (Prescribed Route) (No. ) Traffic Order 198 and the Croydon (Waiting and Loading Restriction) (Amendment No.,) Order 198 under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974;

(b) the Croydon (Parking Places) (Revocation No. ) Order 198 under sections 35 and 84D of the abovementioned Act of 1967, as amended by the abovementioned Act of 1968.

2. The effect of the Croydon (Parking Places) (Revocation No. ) Order 198 would be to revoke the designation by

No. ) Order 198 would be to revoke the designation by the Croydon (Parking Places) (No. 1) Order 1977 of the 2-hour, metered parking place situated in High Street, Croydon.

3. The restrictions imposed by the Croydon (Waiting and Loading Restriction) Order 1977 would apply to the area previously designated as a parking place as they apply in the immediate vicinity.

4. The effect of the Croydon (Prescribed Route) (No. ) Traffic Order 198 would be to prohibit the right turn by vehicular traffic from Katharine Street into High Street, Croydon:

This prohibition would not apply-

(a) to a stage carriage, a schedule express carriage, a school bus or a works bus;
(b) in respect of anything done—
(i) with the permission of the direction of the permission of the direction o

(i) with the permission or at the direction of a police constable in uniform;

(ii) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

- 5. The general effect of the Croydon (Waiting and Loading Restriction) (Amendment No.) Order 198 would be further to amend the Croydon (Waiting and Loading Restriction) Order 1977, so that, in addition to the existing restrictions on waiting by vehicles, waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle would be prohibited between—
  - (a) 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of street specified in Schedule 1 to this notice;

(b) 4.30 p.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 2 to this notice.

6. The prohibitions referred to in paragraph 5 above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up

or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc.
