#### TOWN AND COUNTRY PLANNING ACT 1971

#### TOWN AND COUNTRY GENERAL REGULATIONS 1976

The Minister of Transport hereby gives notice that he has made an Order entitled "The Conversion of Highways into Footpaths or Bridleways (District of Leeds No. 1) Order 1980". The Order comes into operation on 13th October 1980 and extinguishes any right which persons may have to use vehicles (other than those specified in Schedule 2 to the Order) on a length of Colton Road and a length of Meynell Road, Colton, Leeds 15, as from the date on which certain new highways have been provided and are open for use by vehicles. and are open for use by vehicles.

Copies of the Order may be obtained, free of charge, by applying to the Regional Controller's Office (Roads and Transportation), Department of Transport, Yorkshire and Humberside Region, Room 913, City House, New Station Street, Leeds LS1 4JD (quoting Ref. DYH5114/41/7/08), and may be inspected at all reasonable hours at the Department of Planning, Merrion House, Merrion Centre, Leeds LS1 8J Leeds LS2 8JJ.

If any person aggrieved by the Order desires to question its validity, or the validity of any provision contained in it, on the ground that it is not within the powers con-ferred by the above Act or that any requirement of that Act or of any regulations made under it has not been complied with in relation to the Order, he or she may, within 6 weeks from 13th October 1980, apply to the High Court for the suspension or quashing of the Order or of any provision contained in it. Unless the Order is suspended or quashed as a con-sequence of any such application, any person who on 13th October 1980 had an interest in land having lawful access to a highway to which the Order relates may claim
