# Rights of Way Suspended

The Parish of Swillington

1. Part of Footpath No. 27 which runs from Fleakingley Bridge in a general southerly direction to its junction with Astley Lane at a point about 330 metres east-south-east of Astley House being that part which extends from a point about 310 metres north-east of Astley Farm in a general south-south-easterly direction for a distance of about 450 metres to its termination.

2. Footpath No. 28 which runs from its junction with Astley Lane at a point about 70 metres north-west of Astley Farm in a north-easterly direction for a distance of about 305 metres to its junction with Footpath No. 27 referred to in paragraph 1\_above at a point about 275 metres northeast of Astley Farm.
