The County Council of Isle of Wight (Shide Road to Coppins Bridge, Medina Avenue Link and Coppins Bridge Roundabout Extension Classified Roads) (Side Roads) Order 1980.

The County Council of Isle of Wight (Coppins Bridge Roundabout Extension Bridge) Scheme 1980

The County Council of Isle of Wight (Newport South Eastern Relief Road) Compulsory Purchase Order 1980

Notice is hereby given that Public Local Inquiries will be held by Mr. L. G. Vincent, C.B.E., F.R.I.B.A., Dist.T.P., F.R.T.P.I. (a person appointed by the Minister of Transport for the purpose) beginning at 10.30 a.m. on Monday, 24th November 1980, in the Council Chamber, County Hall, Newport, Isle of Wight, in connection with the above-mentioned Orders and Scheme, when representations from persons who have objected to the Orders and Scheme and, at the Inspector's discretion, from any other persons who desire to appear, will be heard.

The Orders and Scheme which will be considered at the inquiries are described as follows:

(1) The County Council of Isle of Wight (Shide Road to Coppins Bridge, Medina Avenue Link and Coppins Bridge Roundabout Extension Classified Roads) (Side Roads) Order 1980. This is an Order under sections 1, 3 and 62 of the Highways Act 1971, which, if confirmed, will authorise the County Council of Isle of Wight:

- (i) to carry out the improvement of highways;
- (ii) to stop up highways;
- (iii) to construct new highways;
- (iv) to stop up private means of access to premises; and
- (v) to provide new means of access to premises;

all at Newport in the Borough of Medina in the County of Isle of Wight.

(2) The County Council of Isle of Wight (Coppins Bridge Roundabout Extension Bridge) Scheme 1980. This Scheme is a Scheme under section 3 of the Highways (Miscellaneous Provisions) Act 1961, which, if confirmed, will authorise the County Council of Isle of Wight to construct a bridge over the navigable waters of the River Medina as part of the proposed highway to be constructed between the Coppins Bridge Roundabout and Shide Road at Newport in the Borough of Medina in the County of Isle of Wight.

(3) The County Council of Isle of Wight (Newport South Eastern Relief Road) Compulsory Purchase Order 1980. This Order is an Order under section 214 of the Highways Act 1959 and sections 44 and 47 of the Highways Act 1971, which, if confirmed, will

authorise the County Council of Isle of Wight to purchase compulsorily the land described therein for the purpose of:

- (i) the construction of new highways;
- (ii) the construction and improvement of highways and the provision of new means of access to premises in pursuance of the above-mentioned Side Road Order;
- (iii) the construction of a bridge in pursuance of the above-mentioned Bridge Scheme;
- (iv) the diversion of a watercourse and the carrying out of other works on watercourses in connection with the construction and improvement of highways as aforesaid;
- (v) use by the said County Council in connection with the aforesaid purposes.

Copies of the above-mentioned Orders and Scheme and of the plans referred to therein have been deposited and may be seen at all reasonable hours free of charge at the County Hall, Newport, Isle of Wight, and at the offices of the Regional Controller (Roads and Transportation), South Eastern, Departments of the Environment and Transport, 74 Epsom Road, Guildford, Surrey.

Proceedings on the above-mentioned Orders and Scheme are being taken concurrently by virtue of section 53 of the Highways Act 1971.

The Minister hereby directs that any person who intends at the inquiries to submit that any highway or proposed highway to which the Orders and Scheme relate should follow an alternative route, or that, instead of improving, diverting or altering a highway to which the Orders and Scheme relate a new highway should be constructed on a particular route, shall send to him at the offices of the Regional Controller at the above address not later than 5th November 1980 sufficient information about the alternative route or the route of the new highway, as the case may be, to enable it to be identified. Failure to comply with this direction will entitle the Minister and the person holding the inquiries to disregard so much of any objection as consists of such a submission.

South Norfolk District Council (Surlingham No. 1) Public Path Extinguishment Order 1980

Notice is hereby given that the above named Order, made on 8th October 1980, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the South Norfolk District Council.

The effect of the Order, if confirmed without modification, will be to extinguish that part of footpath 4 at Surlingham passing through the curtilage of "Riverscourt" in O.S. parcel 3951.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at South Norfolk House, Swan Lane, Long Stratton, between 8.45 a.m. and 4.15 p.m. on Mondays to Fridays.

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the Council, South Norfolk District Council, South Norfolk House, Swan Lane, Long Stratton, Norwich NR15 2XE, before 3rd November 1980, and should state the grounds on which it is made. If no representations or objections are duly made, or if any so made are withdrawn, the South Norfolk District Council may, instead of submitting the Order to the Secretary of State, itself confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
