Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to a highway to which the Order relates shall be entitled to be compensated by the Stockton-on-Tees Borough Council as the local planning authority in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.

# The Trunk Road (Beedon Bypass) (Prohibition of Left-Hand Turn) Order 1980

The Minister of Transport has made an Order under section I of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 on the Winchester-Preston Trunk Road (A34).

The effect of the Order which comes into operation on 21st October 1980 is to prohibit vehicles travelling northwards on the Beedon Bypass turning left on to the superseded length of trunk road (Beedon Hill). The latter is to act as a slip road and carry traffic in a northerly direction only (this is the subject of an Order promoted by the Berkshire County Council).

Any person who desires to question the validity of or of any provision contained in the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may, within 6 weeks of 16th October 1980, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

roads as from the date when the Order comes into operation; and

(c) provide that lengths of the London-Penzance Trunk Road (A303) to be superseded by the new trunk roads on the main route mentioned at (a) above shall cease to be a trunk road, and shall be classified as a classified road, except for the length of trunk road between the Parkhouse roundabout and its junction with the realigned section of A338, to be provided under the London-Penzance Trunk Road (Thruxton-Amesbury Section Side Roads) Order 1980, which shall be classified as a principal road, as from the date on which the Minister notifies the County Councils of Hamp-shire and Wiltshire (who will become the highway authorities responsible for those lengths) that the said new trunk roads are open for through traffic.
