

The alternative route is from Footpath No. 1, Borwick 25 yards (23 metres) north-north-west of its junction with Borwick Road in a north-westerly direction for 30 yards (27 metres) and then in a northerly direction for 110 yards (101 metres) to rejoin Footpath No. 1, Borwick.

A copy of the Order as confirmed and a map contained in it has been deposited at the offices of the Lancaster City Council, Town Hall, Lancaster and at my offices and may be inspected free of charge, during normal office hours.

This Order becomes operative on 31st October 1980, but if any person aggrieved by the Order desires to question the validity thereof, or, of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1959, as amended, or on the ground that a requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order, they may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 7 to the Act within 6 weeks from 17th October 1980, make application to the High Court for the purpose.

The Northavon District Council (LWB. 55, LWB. 56, LWB. 58—Winterbourne) Public Path Extinguishment Order 1980.

Notice is hereby given that the above-named Order, made on 15th October 1980, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the Northavon District Council.
