The length of Public Footpath No. 54 in Tredegar Community to be diverted is its whole length and commences at its junction with Public Footpaths No. 51, 53B and 53C and proceeds in a mainly north-westerly direction to join Public Footpaths No. 55 and 56 a distance of 220 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "M—O".

Public Footpath No. 55

The length of Public Footpath No. 55 in Tredegar Community to be diverted is its whole length which commences at its junction with Public Footpath No. 54 and 56 and runs in a mainly north-westerly direction to its junction with Public Footpaths No. 74 and 74A a distance of 180 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "O—T".

Public Footpath No. 56

The length of Public Footpath No. 56 in Tredegar Community to be diverted commences at its junction with Public Footpaths No. 54 and 55 and proceeds in a mainly northerly direction for a distance of 443 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "O—U".

Public Footpath No. 59

The length of Public Footpath No. 59 in Tredegar Community to be diverted is its whole length and commences at its junction with Public Footpaths No. 74A and 74B and proceeds in a mainly northerly westerly and north-westerly direction to join Public Footpaths No. 81 and 82B a distance of 350 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "W—BB".

Public Footpath No. 67

The length of Public Footpath No. 67 in Tredegar Community to be diverted is its whole length which commences at its junction with Public Footpath No. 45B and proceeds in a mainly north-easterly direction for a distance of 370 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "K—L".

Public Footpath No. 74

The length of Public Footpath No. 74 in Tredegar Community to be diverted is its whole length which commences at its junction with Public Footpaths No. 55 and 74A and proceeds in a mainly north-westerly direction to join Public Footpaths No. 74B and 76 a distance of 66 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "T—V".

Public Footpath No. 74A

The length of Public Footpath No. 74A in Tredegar Community to be diverted is its whole length and commences at its junction with Public Footpaths No. 55 and 74 and proceeds in a mainly westerly direction to join Public Footpaths No. 74B and 115 a distance of 70 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "T—W".

Public Footpath No. 74B

The length of Public Footpath No. 74B in Tredegar Community to be diverted is its whole length which commences at its junction with Public Footpaths No. 74A and 115 and proceeds in a mainly north-easterly direction to join Public Footpaths No. 74 and 76 a distance of 70 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "W—V"

Public Footpath No. 75

The length of Public Footpath No. 75 in Tredegar Community to be diverted is its whole length which runs from its junction with Public Footpaths No. 75A and 81 and proceeds in a mainly north-westerly direction to join Merthyr Road a distance of 83 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "Y—Z"

Public Footpath No. 75A

The length of Public Footpath No. 75A in Tredegar Community to be diverted is its whole length and commences at its junction with Public Footpaths No. 76 and

76A and proceeds in a mainly north-westerly direction to join Public Footpaths No. 75 and 81 a distance of 220 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "X—Y".

Public Footpath No. 76

The length of Public Footpath No. 76 in Tredegar Community to be diverted is its whole length and commences at its junction with Public Footpaths No. 74 and 74B and proceeds in a mainly northerly direction to join Public Footpaths No. 75A and 76A a distance of 70 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "V—X".

Public Footpath No. 76A

The length of Public Footpath No. 76A in Tredegar Community to be diverted is its whole length and commences at its junction with Public Footpaths No. 75A and 76 and proceeds in a mainly north-easterly direction to join Merthyr Road a distance of 290 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "X—AA".

Public Footpath No. 81

The length of Public Footpath No. 81 in Tredegar Community to be diverted is its whole length and commences at its junction with Public Footpaths No. 59 and 82B and proceeds in a mainly north-easterly direction to join Public Footpaths No. 75 and 75A a distance of 233 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "BB—Y".

Public Footpath No. 82

The length of Public Footpath No. 82 in Tredegar Community to be diverted is its whole length which commences at its junction with Public Footpaths No. 82A and 82B and proceeds in a mainly south-easterly direction for a distance of 90 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "CC—DD".

Public Footpath No. 82A

The length of Public Footpath No. 82A in Tredegar Community to be diverted is its whole length which commences at its junction with Public Footpaths No. 82 and 82B and proceeds in a mainly north-westerly direction to join Merthyr Road a distance of 120 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "CC—EE".

Public Footpath No. 82B

The length of Public Footpath No. 82B in Tredegar Community to be diverted is its whole length which commences at its junction with Public Footpaths No. 59 and 81 and proceeds in a mainly north-westerly direction to join Public Footpaths No. 82 and 82A a distance of 106 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "BB—CC".

Public Footpath No. 87

The length of Public Footpath No. 87 in Tredegar Community to be diverted is its whole length and commences at the joint Gwent/Mid Glamorgan County Boundary and its junction with Cartroad/Footpath No. 7 in Rhymney and proceeds in a mainly north-easterly direction to join Public Footpaths No. 125 and 89 a distance of 80 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "FF—GG".

Public Footpath No. 89

The length of Public Footpath No. 89 in Tredegar Community to be diverted commences at its junction with Public Footpath No. 87 and 125 and proceeds in a mainly north-easterly direction for a distance of 66 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "GG—JJ".

Public Footpath No. 115

The length of Public Footpath No. 115 in Tredegar Community to be diverted commences at its junction with Public Footpaths No. 53C and 53D and proceeds in a mainly north-easterly direction to join Public Footpaths No. 74A and 74B a distance of 350 yards or thereabouts and as shown on the plan annexed hereto in a solid red line and marked "R—W".
