AVON COUNTY COUNCIL

County of Avon (Windsor Bridge Road (A3604), City of Bath) (Restricted Road) Order 1980

Notice is hereby given that on 16th October 1980 the County Council of Avon made an Order, with the consent of the Minister of Transport, under sections 72 (3) and 73 (1) of the Road Traffic Regulation Act 1967, as amended, the effect of which is that no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on that length of Windsor Bridge Road (A3604), in the City of Bath, which extends from its junction with Lower Bristol Road (A36) to its junction with Upper Bristol Road (A4) a distance of approximately 0.29 kilometres.

BEDFORDSHIRE COUNTY COUNCIL

The County of Bedfordshire (40 m.p.h. Speed Limit) (No.) Order 19

Notice is hereby given that the County Council of Bedfordshire propose to apply to the Minister of Transport under section 84B of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 for consent to make an Order under section 74 (1) of the Road Traffic Regulation Act 1967 prohibiting the driving of any motor vehicle at a speed exceeding 40 m.p.h. on the following length of road in Lower Stondon:

That length of Bedford Road (Route A600) which extends from a point 150 metres north-west of its junction with Hitchin Road (Route A6001) in a south-easterly direction for a distance of 840 metres.

IPSWICH BOROUGH COUNCIL

ROAD TRAFFIC REGULATION ACT 1967, SECTION 1

The Borough of Ipswich (London Road (South) General Improvement Area) (Experimental Traffic Regulation Scheme) Order 1980.

Notice is hereby given that the Ipswich Borough Council acting as Agents for and on behalf of the Suffolk County Council propose to make an Order under the provisions of section 9 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

When this Order comes into effect Elliott Street will become one way in a southerly direction; Stevenson Road one way in a northerly direction; Elliott Street, Gibbons Street, Dillwyn Street, Dillwyn Street West, Emlen Street and Stevenson Road subject to "No entry except for Access" provisions and existing waiting restrictions in these roads will be revoked. In addition regulations designed to provide increased protection at junctions "No waiting at any time" will be introduced in respect of the Handford Road, Burlington Road and London Road junctions. Full details of these proposals are contained in the draft Order which, together with a map showing the restricted areas
