Noise Abatement Order 1980*

Notice is hereby given that the Stockport Metropolitan Borough Council (hereinafter called "the Council") in exercise of their powers under section 63 of the Control of Pollution Act 1974 on 17th October 1980, made the Metropolitan Borough of Stockport (No. 2) Noise Abatement Order 1980.

The general effect of the Order if confirmed will be to enable the Council to control noise from premises of the following classes by establishing the current noise levels and using these as reference levels for the control of noise from the premises in the future:

- (i) industrial premises (including garages at which repairs are undertaken);
- (ii) places of entertainment.

The boundaries of the area covered by the Order are Dialstone Lane, New Zealand Road, Stockport Road, Peak Forest Canal, Green Lane and Dooley Lane, Torkington Brook, the disused railway line, the boundary with Macclesfield Metropolitan Borough and the A6 London Road.

The area covered by the Order is shown coloured green on the map attached to the Order and the premises affected at the date thereof are edged red on the map. The Order will become operative 12 months from the date of confirmation by the Secretary of State.

A copy of the Order and of the map referred to may be inspected free of charge by any person during normal office hours at the Enquiry Desk, Town Hall, Stockport, during the period up to 12th December 1980, and any person who will be affected by the Order, may, within that period by notice to the Secretary of State for the Environment, Queen Anne's Chamber, 28 Broadway, London, object to the confirmation by him of the Order.

THE CONTROL OF POLLUTION ACT 1974

The Chiltern No. 1 Noise Abatement Order 1980

Notice is hereby given that in exercise of the powers conferred upon them by section 63 of the Control of Pollution Act 1974, the Chiltern District Council have made the Chiltern No. 1 Noise Abatement Order 1980 which designates the area bounded by Chilton Road, Nutkins Way, Addison Road and Berkhamstead Road, Chesham, as a Noise Abatement Zone, within which noise from premises in the following classifications will be controlled:

1. Industrial Premises.
2. Commercial Premises, excluding offices and retail shops.
3. Transport Installations.
4. Public Utility Installations.

All classified premises within the Zone will have recorded in a public register, a measured noise level which must not be exceeded without written authority from the Council.

When as a result of construction or other works a premises which is subject to control is established, the Council may determine the level of noise which will be acceptable from those premises.

A copy of the Order and the map referred to therein will be on deposit at the Council Offices, Elmodesham House, 42 High Street, Amersham and at the Environmental Health Office, 80-82 The Broadway, Chesham, where they may be inspected by any person at all reasonable times free of charge during the period ending on 8th December 1980.

Objections

ST. HELENS BOROUGH COUNCIL

CLEAN AIR ACT 1956

St. Helens (No. 23) Smoke Control Order 1980

Notice is hereby given that the St. Helens Borough Council in exercise of the powers conferred upon them by section 11 of the above-mentioned Act on 22nd October 1980, made an Order entitled "The St. Helens (No. 23) Smoke Control Order 1980", declaring the area described in the First Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the limitations and exemptions provided by the Order and by virtue of section 11 (2) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

The buildings in the area specified in the Second Schedule hereto are exempted from the operation of the Order.

If confirmed the Order will not come into operation before 1st November 1981, or before a later date determined by the Department of the Environment.

Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Town Hall, St. Helens and at the Council's Area Office, Market Street, Newton-le-Willows at all reasonable hours during the period of 6 weeks from 31st October 1980.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary of State for the Environment, Department of the Environment, Sunley Building, Piccadilly Plaza, Manchester 7, object to the confirmation of the Order.
