The Secretary of State for Wales hereby gives notice that he proposes to make the following Orders:

1. An Order under section 7 of the Highways Act 1959 providing:

(a) that a road which he proposes to construct at Pont Rhydsarn Llanuwchllyn in the county of Gwynedd shall become a trunk road as from the date when the Order comes into operation, and

(b) that the length of the Dolgellau—South of Birkenhead Trunk Road to be superseded shall cease to be a trunk road as from the date on which notice is given by him to the County Council of Gwynedd that the new length of trunk road is open for through traffic, and

2. An Order under section 9 of the Highways Act 1959 authorising him to stop up a length of the Dolgellau—South of Birkenhead Trunk Road at Pont Rhydsarn Llanuwchllyn aforesaid.

In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
