The Licensed Non-residential Establishment Wages Council hereby gives notice of proposals for varying the statutory minimum remuneration and holidays and holiday remuneration as set out in (1) the Wages (Licensed Non-residential Establishment (Bar Staff) Order 1980 (Order LNR (135))); (2) the Wages (Licensed Non-Residential Establishment (Club Stewards) Order 1980 (Order LNR (136))); and (3) the revocation of Orders LNR (135) and LNR (136).

The Wages Council intends that the revised provisions shall come into operation on 15th January 1981.

Particulars of the proposals are contained in the Wages Council's Notices LNR (137) and LNR (138) copies of which may be obtained on application to the Secretary of the Wages Council at the address given below. The Wages Council will consider any written representation with respect to the proposals if made within 28 days from 24th October 1980. NEW TOWNS ACT 1965

Extinguishment of Public Rights of Way, The New Town of Basildon, Parts of Rectory Road, Felmore 3D and 3E Housing Areas.

Notice is hereby given that the Secretary of State for the Environment in exercise of his powers under section 23 of the New Towns Act 1965, proposes to make an Order extinguishing all public rights of way over the following highway shown coloured blue on the map (Ref. EO/8757/2) hereinafter referred to:

That part of the Western side of Rectory Road from a point marked A on the map approximately 35 feet from its junction with Oakdene Road running in a southerly direction for a distance of approximately 315 feet to a point marked B on the map, forming a triangular shape with a width of approximately 22 feet at the southernmost side.

That part of the Eastern side of Rectory Road from a point marked C on the map approximately 6 feet south of its junction with Oakdene Road, running in a southerly direction for approximately 395 feet to a point marked D on the map, forming a triangular shape with a width of approximately 15 feet at its northernmost side.

A map showing the rights of way proposed to be extinguished may be inspected at the offices of the Basildon Development Corporation, Gifford House, London Road, Bowers Gifford, Basildon, Essex, and the offices of the Basildon Council, Fodderwick, Basildon, Essex, during normal office hours.

Any objection to this proposal must be made in writing clearly stating all the grounds of objection and addressed to the Secretary of State for the Environment, 2 Marsham Street, London SW1P 3EB (Ref. NT/5455/U35/3/4) not later than 24th November 1980.
