Leasowe Revetment Reconstruction Stage III

Notice is hereby given that the Wirral Borough Council acting in their capacity as coast protection authority hereby give notice under sub-section (1) of section 5 of the above Act that they propose to carry out coast protection work as described herein.

Stage III will be the final phase in the authority's programme for complete reconstruction of the Leasowe Revetment.

The works involve reslabbing in concrete, four hundred (400) metres of revetment at the eastern end to link existing new construction opposite Derby Bathing Pool, with Kings Parade. The existing slipway at Kings Parade will be improved and reinforced concrete wave absorption blocks will be provided along the return between Leasowe Revetment and Kings Parade. These blocks will be laid to a regular conformation supported by a steel sheet pile toe over a length of approximately eighty-eight (88) metres followed by an end return from this construction to the existing seawall adjacent to the coastguard lookout, of natural armour stone laid to a general gradient of 1 in 6.

The western end of the revetment will be demolished over a length of eighty-eight (88) metres and replaced by a shore linked armour stone breakwater. The breakwater will extend approximately one hundred and fifty (150) metres offshore and provide protection against wave attack to the western extremity, whilst also promoting the build-up of beach sand along the toe of the revetment, in this area.

East of the breakwater, the remaining forty-five (45) metres of existing revetment, faced with interlocking concrete blocks, will be linked to Stage I of the reconstruction work by a transition section using the same wave absorption blocks.
