DEVON COUNTY COUNCIL

The County of Devon (Exeter Street Area, Plymouth) (Traffic Regulation) Amendment Order 1980

Notice is hereby given that the Devon County Council propose to make an Order under section 1 and 84D of the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

- (a) To prohibit the waiting of vehicles at any time and also the loading and unloading of vehicles between the hours of 8 a.m. and 9.15 a.m. and 4.15 p.m. to 6.15 p.m., Monday to Saturday on parts of the north and south sides of Exeter Street, parts of the north-west and south-east sides of Bretonside, parts of the south-west and north-east sides of Sutton Road, parts of both sides of Alma Street and parts of both sides of Holborn Street.
 (b) To limit the waiting of vehicles for more than 1 hour in any period of 4 hours from 9 a.m. to 4.15 p.m. Monday to Saturday on part of the north side of Exeter Street.
 (c) To prohibit the waiting of vehicles for a longer period than 30 minutes in any hour between the hours of 8 a.m. to 6.30 p.m., Monday to Saturday on part of the north side of Exeter Street.
 (d) To prohibit the waiting of vehicles and the loading and unloading of vehicles between the hours of 4.15 p.m. to 6.15 p.m., Monday to Saturday, on part of the north side of Exeter Street.
 (e) To prohibit the waiting of vehicles between the hours of 8 a.m. to 8 p.m. Monday to Saturday on parts of the east and west sides of Sutton Road.
 (g) To prohibit the waiting of vehicles for more than 1 hour in any period of 4 hours, from 8 a.m. to 8 p.m., Monday to Saturday on part of the west side of Sutton Road.
 (h) To rescind The County of Devon (Exeter Street, Plymouth) (Prohibition and Restriction of Waiting) Order 1976, The City of Plymouth (Exeter Street Cattedown Roundabout) (Prohibition of Waiting) Order 1972, The City of Plymouth (Exeter Street) (Restriction of Waiting, Loading and Unloading) Order 1970, The City of Plymouth (Exeter Street) (Prohibition and Restriction of Waiting) Order 1968 and The City of Plymouth (Sutton Road) (Restriction of Waiting) Order 1969.
 (i) To rescind The City of Plymouth (Radial Roads Number 3) (Traffic Regulation) Order 1966 insofar as it relates to Exeter Street.

Exceptions will be provided in the Order permitting waiting for the purpose of boarding and alighting, loading and unloading, except between the above restricted hours, building and demolition, roadworks and the maintenance of essential services. Exceptions will also be provided for vehicles used by disabled persons in accordance with the Orange Badge Scheme.

DUDLEY METROPOLITAN BOROUGH

The Borough of Dudley (Forge Lane, Halesowen) (Prohibition of Waiting) (Amendment) Order 1980
