##### NOTICE OF PUBLIC PATH ORDER HIGHWAYS ACT 1959

*The District of Daventry (Bridleways EY12 and FF8) (Parishes of Long Buckby and Watford) Public Path Diversion Order 1980*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 25th September 1980, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Daventry District Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert a length of bridleway EY12 in the Parish of Long Buckby which extends from a point east of Murcott House on the Long Buckby/Watford county road in a northward direction for a distance of approximately 370 metres to its junction with bridleway FF8 at the Watford Parish Boundary together with that length of bridleway FF8 in the Parish of Watford which extends from its junction with bridleway EY12 at the Parish Boundary in a northward direction for a distance of approximately 512 metres to a new bridleway approximately 395 metres in length in the Parish of Long Buckby leading from a point adjacent to the watercourse east of Murcott House on the Long Buckby/Watford county road in a general northward direction to the Watford Parish Boundary together with a new length of bridleway in the Parish of Watford which extends from its junction with the Long Buckby Parish Boundary in a general northward direction for a distance of approximately 570 metres to join the existing bridleway FF8.

A copy of the Order and the map contained in it has been deposited at my office and may be inspected free of charge during normal office hours.

Any representation or objection with respect to the Order may be sent in writing to the Chief Executive Officer Daventry District Council, Council Offices, Church Walk, Daventry, not later than 21st November 1980 and should state the grounds on which it is made.

If no representations or objections are duly made or if any so made are withdrawn, the Daventry District Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

##### PUBLIC PATH DIVERSION ORDER HIGHWAYS ACT 1959

*The District of Daventry (Footpath DD4) (Parish of Moulton No. 2) Public Path Diversion Order 1980*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 25th September 1980, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Daventry District Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert a length of footpath DD4 in the Parish of Moulton which extends from the south-east corner of OP 3700 in a general north-west and south-west direction for a distance of approximately 312 metres to an alternative public footpath approximately 421 metres in length which leads from the south-east corner of OP 3700 in a general south-westerly and north-westerly direction along the boundary of OP 3700 and OP 2300 to rejoin the existing footpath DD4.

*The Hampshire (Basingstoke and Deane Borough No. 14) (Parish of Wootton St. Lawrence—Footpath No. 16 and Parts of Footpath No. 17) Public Path Diversion Order 1980.*

Notice is hereby given that on 3rd October 1980, the Hampshire County Council confirmed the above-named Order.
