The City of York (Various Streets) (Bus Stop Clearways and Prohibition of Waiting) Order 1980

Notice is hereby given that the York City Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the North Yorkshire County Council in the exercise of the powers of the County Council under sections 1, 28 and 84D (1) of the Road Traffic Regulation Act 1967, as amended, propose to make an Order the effect of which will be to:

- Introduce Bus Stop Clearways at a number of Bus Stops in the city. Waiting by vehicles is prohibited in Bus Stop Clearways during the hours 7 a.m. to 7 p.m. throughout the week except for very limited purposes, i.e.:
  - (a) if the vehicle is being used for the removal of any obstruction to traffic;

The Bus Stops concerned are as follows:

Bishopthorpe Road, outside Nos. 6-12 Bishopthorpe Road.

Blossom Street, the two stops adjoining the Odeon and the three stops on its south-east side near to its junction with Nunnery Lane.

Clarence Street, the two stops outside and opposite Nos. 54-60 Clarence Street.
