(c) Building operations road and similar works.

Any person who desires to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended as aforesaid, or on the grounds that any requirements of that Act or any instrument made under it has not been complied with in relation to the Order may within 6 weeks of 27th October 1980 apply to the High Court for this purpose. Exemptions will be included which will permit waiting for disabled persons' vehicles and for the purposes of picking up and setting down passengers, loading and unload-

ing goods, the maintenance of the roads, and work in connection with the supply of gas, electricity and water.
