NOTICE OF PROPOSAL TO ABSTRACT WATER

Notice is hereby given that the Anglian Water Authority propose by virtue of a Licence Serial No. 4/29/7/G/29 which shall be deemed to have been granted by the Secretary of State for the Environment to abstract from the underground strata (limesone) at National Grid Reference SE 964197 in the Parish of Winterton in the Borough of Glanford in the County of Humberside (Winterton Pumping Station) a maximum of 4,546 cubic metres (approximately 1,000,000 gallons) of water during any period of 24 hours provided that the abstraction of water in pursuance of such licence in any one year when combined with and added to the quantities of water abstracted in that year at Scotney Pumping Station in pursuance of Licence of Right 4/29/7/G/6 and at Winterton Holmes Pumping Station in pursuance of Licence of Right No. 4/29/7/G/9 shall not exceed 3,636,880 cubic metres (approximately 800,000,000 gallons). The abstracted water will be used for public water supply purposes and the licence will expire on 30th June 1990.

The abstraction of water as described above is a continuation of an abstraction previously authorised.

The Water Authority have placed copies of the draft licence together with a map showing the position of the said Winterton Pumping Station upon deposit at the offices of their Lincolnshire River Division at 50 Wide Bargate, Boston, Lincs. PE21 6SA, and at the depot of their Lincoln Water Division at Winterton Road, Scunthorpe, and at the Northern Area Office of their Lincoln Water Division at Town Hall Square, Grimsby, and such draft licence which includes all the matters appearing to the Authority to be

appropriate may be inspected free of charge at the offices referred to at all reasonable hours during the period of 25 days from the date of the publication of the *London Gazette*.

Representations with respect to the proposals may be made in writing to the Divisional Manager of the Lincolnshire River Division of the Anglian Water Authority at the address stated above before the end of the said period.

After the expiry of the said period the Water Authority will be entitled to pass a resolution by virtue of which the licence authorising the proposals shall be deemed to be granted unless the Secretary of State for the Environment either in consequence of any representations made with respect to the proposals or otherwise requires an application for the licence to be made to him.
