Notice is hereby given that on 21st October 1980 the Lake District Special Planning Board confirmed the above-named Order.

The effect of the Order is to divert the public right of way running from grid reference 32280308 at Hacket Forge, Little Langdale, near Ambleside to grid reference 32220304 to a line running from grid reference 32230309 to grid reference 32220304.

NOTICE OF PUBLIC PATH ORDER

*Leicestershire County Council (Footpaths No. W44 (Part) and No. 60 (Part) Broughton Astley) Public Path Diversion and Extinguishment Order 1980.*

Notice is hereby given that the above-named Order is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Leicestershire County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert that part of public footpath W44 leading from Green Road, Primethorpe to Cottage Lane, Broughton Astley, which lies within the parish of Broughton Astley and extends from a point at grid reference 52479305 in Ordnance Survey (henceforth referred to as O.S.) Parcel No. 5500 in generally south-south-easterly and southerly directions through that parcel to grid reference 52499302, thence entering O.S. Parcel No. 7853 and crossing it in generally south-south-easterly and east-south-easterly directions to a point at the footbridge over the stream at grid reference 52569295, to a line which extends from the point at grid reference 52479305 previously described, in a generally north-easterly direction for a distance of approximately 22 metres to a point at grid reference 52499308 on the north-eastern boundary of O.S. Parcel No. 5500, thence to follow the north-eastern and eastern boundaries of that parcel and continue through O.S. Parcel No. 7853 along the western bank of the water course to rejoin the existing footpath W.44 at grid reference 52569295 previously described.

Also to extinguish that part of public footpath V.60, leading from Arbor Road Croft, to Sutton in the Elms and from Hobby Close, Broughton Astley, to footpath W.44 north of Broughton Astley Primary School which extends from a point at grid reference 52499308, previously described, in a generally southerly direction for a distance of approximately 42 metres to a point at grid reference 52499303 at the junction with existing footpath W.44.

A copy of the Order and relevant map is available for inspection at Room 210, County Hall, Glenfield, Leicester.

Any representation or objection in respect to the Order may be sent in writing to the County Secretary, County Hall, Glenfield, Leicester LE3 8RA, not later than 1st December 1980, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Leicestershire County Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been made and not withdrawn will be sent to the Secretary of State with the Order.
