

## BROXBOURNE BOROUGH COUNCIL

## ROAD TRAFFIC REGULATION ACT 1967 (AS AMENDED)

*The Borough of Broxbourne (Roman Street, Hoddesdon)  
(Prohibition of Waiting) Order 1980*

Notice is hereby given that on 27th October 1980 the Council of the Borough of Broxbourne pursuant to arrangements made with the Hertfordshire County Council, under section 101 of the Local Government Act 1972, and after consultation with the Chief Officer of Police, under section 84C (i) of the Road Traffic Regulation Act 1967, as amended, made an Order under section 1 of the said Act of 1967, the effect of which will be to prohibit any vehicle to wait at any time on both sides of Roman Street, Hoddesdon as specified in the Schedule hereto.

The Order contains exemptions:—

- (a) To enable persons to board or alight from the vehicle.
- (b) To enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road, the side or length of the road so referred to, or the laying, erection, alteration or repair in or near the said road, the said side or length of the road of any sewer or of any main, pipe or apparatus for the supply of gas water or electricity or of any telegraphic line as defined in the Telegraph Act 1878.
- (c) To enable the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in pursuance of statutory powers or duties.
- (d) For any purpose if there is displayed on the vehicle the relevant disabled persons parking badge and the vehicle is left by such a disabled person.

A copy of the Order together with a map contained in it may be inspected at the office of the undersigned during normal office hours.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirements of the Act or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks from the date of publication of this Notice apply to the High Court for this purpose.

## BUCKINGHAMSHIRE COUNTY COUNCIL

*The Buckinghamshire County Council (A4156, Walton Road,  
Aylesbury) (Box Junction) Order 1980*

Notice is hereby given that Buckinghamshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 of the Local Government Act 1972, and Schedule 6 of the Road Traffic Act 1974, the effect of which Order will be:

To prohibit any vehicle to enter the boxed area on the south-eastern half of the carriageway of Walton Road at its junction with Walton Grove whilst other stationary vehicles are preventing them from leaving it unless such vehicle is queuing to turn right, and then prevented from leaving the junction only by moving traffic or by other vehicles waiting to complete a right turn.

To prohibit any vehicle to remain stationary in the above specified boxed area when endeavouring to make a right hand turn if the exit in that direction is blocked.

Exemptions to the proposed Order shall apply to permit the following:

- (a) anything done on the direction or with the permission of a police constable in uniform or a traffic warden;
- (b) a vehicle being used for police, fire brigade or ambulance purposes;

(c) if the driver of a vehicle, when entering the boxed area had reasonable cause to believe that he would immediately be able to leave it.

A copy of the proposed Order and a map showing the lengths of road referred to, with a copy of the Statement of Reasons for proposing to make the Order may be inspected at County Hall, Aylesbury during normal office hours.

Objections to the proposal together with the grounds on which they are made must be sent in writing to the undersigned by 26th November 1980.

## NORTH HERTFORDSHIRE DISTRICT COUNCIL

*The North Hertfordshire District Council (Sun Street and Bridge  
Street, Hitchin) (Prescribed Route) Order and the (Sun Street and  
Tilehouse Street, Hitchin) (Prohibition of Right Hand Turn)  
(Revocation) Order 1980*

Notice is hereby given that the North Hertfordshire District Council acting as agents for the Hertfordshire County Council made an Order on the 28th October 1980 under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which from the 5th November 1980, is to require vehicles proceeding in a southerly direction in Sun Street, Hitchin, on reaching the junction with Bridge Street, to make a left turn into Bridge Street.

The present Order, prohibiting vehicles from making a right turn from Sun Street into Tilehouse Street has been revoked.

## STAFFORD BOROUGH COUNCIL

*The Borough of Stafford (Gaoigate Street, Stafford) (Bus Lane and  
Prohibition of Driving) Order 1979*

## PUBLIC INQUIRY

Notice is hereby given that a Public Inquiry into the proposal of Stafford Borough Council to make the above-mentioned Order will be held by Mr. W. Wood, LL.B., in the Committee Room, Riverside Recreation Centre, Stafford on Wednesday, 10th December 1980 at 2 p.m.

The effect of the proposed Order (made under section 1 (1), (2) and (3) of the Road Traffic Regulation 1967 as amended by Part IX of the Transport Act 1968) if confirmed by the Minister for Transport, will be as follows:

To impose a restriction of entry on traffic travelling in both directions along that part of Gaoigate Street, Stafford between its junction with Gao Square and Stafford Street (this restriction will not apply to stage carriages and pedal cycles) and will contain exemptions in respect of Nos. 28 29 and 30 Gaoigate Street, Stafford.
