In particular, a building in a Conservation Area shall not be demolished without the consent of the local planning authority, demolished without the consent of the local planning authority, and an application for such consent may be made thereto either separately or as part of a planning application to re-develop the site. The 1974 Act also extends the controls over trees in Conservation Areas. Subject to certain exemptions, any person wishing to fell, top, lop etc., trees in such Areas should give the Borough Council 6 weeks' notice of intention to do so. Penalties apply in the event of violations of these controls.
