*The Borough of Gillingham (Off-Street Parking Places) Order, 1970 (Amendment No. 16) Order 1980*

Notice is hereby given that on 7th November 1980 the Gillingham Borough Council made an Order under section 31 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Local Government Act 1974, the effect of which will be to make provision for quarterly season tickets to be made available for use at the Dalton Street Car Park at a charge of £12 per quarter.

## MID GLAMORGAN COUNTY COUNCIL

*Mid Glamorgan County Council (Holly Street/Lime Street, Rhydyfelin) (Prohibition of Left and Right Hand Turns) Order 1980*

Notice is hereby given that on 28th October 1980 the Mid Glamorgan County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is :

- (i) To prohibit any vehicle proceeding in a north easterly direction in Lime Street, Rhydyfelin from making a right hand turn into Holly Street, Rhydyfelin, at its junction with that road.
- (ii) To prohibit any vehicle proceeding in a north-westerly direction in Holly Street, Rhydyfelin from making a left hand turn into Lime Street, Rhydyfelin at its junction with that road.

The Order came into operation on 7th November 1980 and a copy thereof and a map showing the roads to which the Order relates may be inspected at the offices of the Mid Glamorgan County Council, Cathays Park, Cardiff, during normal office hours until the end of 6 weeks from the 7th day of November, 1980.

## MID GLAMORGAN COUNTY COUNCIL

*Mid Glamorgan County Council (Bute Street (Route A4061) Treherbert) (Prohibition of Waiting) Order 1980.*

Notice is hereby given that on 28th October 1980 the Mid Glamorgan County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit the waiting of vehicles at any time on the sides of lengths of road described in the Schedule to this notice.

Exemptions are provided in the Order for the purposes of boarding, alighting, loading and unloading, building and roadworks, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled persons' vehicles displaying the relevant disabled person's badge will be allowed to wait for up to 2 hours with return prohibited within 1 hour.

## MID GLAMORGAN COUNTY COUNCIL

*Mid Glamorgan County Council (Henry Street, Mountain Ash) (Prohibition of Waiting) Order 1980*

Notice is hereby given that on 28th October 1980 the Mid Glamorgan County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit the waiting of vehicles at any time on the north-eastern side of Henry Street, Mountain Ash, from a point 15 metres (16 yards) south-east of the south-eastern corner of the Institute in a south-easterly direction for a distance of 12.5 metres (13 yards).

Exemptions are provided in the Order for the purposes of boarding, alighting, loading and unloading, building and roadworks, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled persons' vehicles displaying the relevant disabled person's badge will be allowed to wait for up to 2 hours with return prohibited within 1 hour.

The Order came into operation on 7th November 1980 and a copy thereof and a map showing the side of length of road to which the Order relates may be inspected at the offices of the Mid Glamorgan County Council, Cathays Park, Cardiff, during normal office hours until the end of 6 weeks from 7th November 1980.
