*The Borough of Rotherham (Grange Lane, Maltby (No. 2))
Public Path Diversion Order 1980*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 14th October 1980, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Rotherham Borough Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the Public Right of Way from a point north of Highfield Park, Maltby (Point A on a map included in the Order) travelling for 10 metres in a north-easterly direction to a point D then turning through approximately 60 degrees and extending for 155 metres in a west-south-westerly direction to a point E situated to the rear of dwelling-house No. 57 Highfield Park and then extending 220 metres in a general northerly direction along the western boundary of Maltby Wood (Grange Quarter) to a point C where it rejoins the existing defined public right of way.
