OXFORDSHIRE COUNTY COUNCIL

Oxfordshire County Council (Leafield) (Restricted Roads) Order 198

Notice is hereby given that the Oxfordshire County Council propose to make an Order under sections 72 (3), 73 (1) and 73 (3) of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to impose a 30 m.p.h. speed limit on the lengths of the roads specified in the Schedule below.

SCHEDULE

Roads in the Parish of Leafield

(1) That length of the *Finstock Road* which extends in an easterly direction from its junction with Fairspear Road to a point approximately 140 metres east of Greenwich Lane, a distance measured along the said length of road of approximately 1,217 metres.

(2) That length of road known as *The Riding* which extends in a southerly direction from its junction with Fairspear Road for a distance measured along the said length of road of approximately 218 metres.

(3) That length of road known as *Fairspear Road* which extends in a north-westerly direction from its junction with the *Finstock Road* and *The Riding* for a distance measured along the said length of road of approximately 320 metres.

(4) The whole length of *Chapel Close*, a distance measured along the said length of approximately 52 metres.

(5) That length of road known as *Witney Lane* extending in a southerly direction from its junction with the *Finstock Road* for a distance measured along the said length of road of approximately 356 metres.

(6) The whole length of *Hewetts Close*, a distance measured along the said length of approximately 140 metres.

(7) That length of road known as *Hatching Lane* which extends in a northerly direction from its junction with the *Finstock Road* for a distance measured along the said length of road of approximately 110 metres.

(8) That length of road known as *Greenwich Lane* which extends in a southerly direction from its junction with the *Finstock Road* for a distance measured along the said length of road of approximately 46 metres.

(9) The whole length of the unadopted housing estate road off *Greenwich Lane* extending in a westerly direction from its junction with *Greenwich Lane*, a distance measured along the said length of road of approximately 108 metres.

(10) That length of road which extends in a north-easterly direction from its junction with *The Riding* to its junction with the *Finstock road*, a distance measured along the said length of road of approximately 230 metres together with the short length of road on the east side of the school linking the *Finstock Road*, a distance of approximately 18 metres.

(11) The whole lengths of all the roads on the north of the *Finstock Road* known as *The Green*.

PRESTON BOROUGH COUNCIL

The Borough of Preston (Service Road to the Market Hall) (Prohibition of Waiting) Order 1980

Notice is hereby given that the Preston Borough Council as agent of the highway authority the Lancashire County Council in exercise of the powers of the said County Council under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Local Government Act 1974 has made the above-mentioned Order on 7th November 1980.

The Order will come into operation on 17th November 1980 and its effect will be to prohibit waiting on the Service Road to the Market Hall and Lowthian House running between Tenterfield Street and the westbound carriageway of Ring Way. It will be subject to the usual exemptions.

A copy of the Order together with a map showing the area affected may be inspected at the Borough Solicitor's Department, Town Hall, Lancaster Road, Preston, during normal office hours.

If you wish to object to the validity of the Order or of any provision contained therein on the ground that it is not within the powers conferred by the above section of the Road Traffic Regulation Act 1967, as amended, or on the ground that any requirement of any section of that Act or any regulations made under it has not been complied with in relation to the Order, you may within 6 weeks from 7th November 1980 apply to the High Court for this purpose.
