#### The Hammersmith and Fulham (Prescribed Routes) (No. 4) Traffic Order 1980

Notice is hereby given that the Greater London Council on 10th November 1980 made the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The effect of the Order will be:

- (a) To prohibit vehicles from entering or leaving Lalor Street at its junction with Fulham Palace Road. (There
- is a barrier in the carriageway at the junction.) (b) To prohibit vehicles from entering that length of the carriageway of:
  - (i) Colehill Lane, which lies between the north-eastern kerb-line of Firth Gardens and a point 2 metres north-east of that kerb-line;
  - (ii) Waldemar Avenue, which lies between a point 13 metres south-east of the south-eastern kerb-line of Burnfoot Avenue and a point 15 metres south-east of that kerb-line.

(There is a barrier in each length of carriageway.) 3. The prohibitions referred to in paragraph 2 above will not apply:

(i) to bicycles (not being motor vehicles) which follow the route through the barrier indicated by traffic signs;

(ii) to vehicles being used for ambulance, fire brigade or

(ii) to vehicles being used for ambulance, fire brigade or police purposes in certain circumstances;
(iii) to anything done with the permission or at the direction of a police constable in uniform;
(iv) to anything done in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.
4. A copy of the Order (which contains plans which indicate the lengths of carriageway referred to in paragraph 2 above) which will come into operation on 16th November 1980, can be inspected during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Order was made in Room B.21,

# HIGHWAYS ACTS 1959 TO 1971

The Greater London Council (York Road, Wandsworth A3205 Classified Road) (Side Roads) Order 1980

The Greater London Council hereby gives notice that they have made, and submitted to the Minister of Transport for confirmation, an Order under sections 1 and 62 of the Highways Act 1971 for authorising the Council:

- (a) to carry out improvements to Plough Road, Lombard Road, Wye Street and Falcon Road;
