### TOWN AND COUNTRY PLANNING ACT 1971

#### ACQUISITION OF LAND (AUTHORISATION PROCEDURE) ACT 1946

##### *Statutory Orders (Special Procedure) Act 1945*

Notice is hereby given, in pursuance of section 2 (1) of the Statutory Orders (Special Procedure) Act 1945, that it is the intention of the Secretary of State for the Environment to lay before Parliament The Fylde Borough Council (St. Albans Road, St. Annes) (Appropriation) Order 1980 confirmed by the Secretary of State for the Environment on 12th November 1980, under the provisions of section 121 of the Town and Country Planning Act 1971, and the Acquisition of Land (Authorisation Procedure) Act 1946. (8 SI)

### NEW TOWNS ACT 1965

*The New Town of Redditch (Extinguishment of Public Rights of Way) Part of Bridleway No. 49, Oakenshaw, Redditch.*

Notice is hereby given that the Secretary of State for the Environment in exercise of his powers under section 23 of the New Towns Act 1965, has made an Order extinguishing the public rights of way over the following bridleway, shown coloured red on the map referred to therein:

Part of Bridleway No. 49, from the east side of Greenlands Drive at a point marked A on the map, then running in a south-westerly direction for approximately 220 metres to a point adjacent to the south-east slip road of the Henley Highway and Bromsgrove Highway interchange marked B on the map, and then southerly for approximately 150 metres to a point on the east side of Greenlands Drive marked C on the map.

Part of Bridleway No. 49, from the east side of the subway under Greenlands Drive at a point marked D on the map, then running in a south-westerly direction for approximately 220 metres to a point 40 metres north-east of the eastern edge of Coldfield Drive marked E on the map, and then westerly for approximately 80 metres to a point on the north side of Coldfield Drive marked F on the map.

Part of Bridleway No. 49 from a point on the north side of the subway under Coldfield Drive at a point marked G on the map, then running in a south-westerly direction for a distance of approximately 190 metres to a point on the east side of High Trees Close at a point marked H on the map.

The Order is dated 4th November 1980, and a copy of it and of the map referred to in it showing the rights of way which have been extinguished and the alternative routes available may be inspected at the offices of the Redditch Development Corporation, Holmwood, Plymouth Road, Redditch, during normal office hours.
