Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 14th November 1980 is about to be submitted to the Secretary of State for Wales for confirmation or to be confirmed by the Alyn and Deeside District Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert the public right of way No. 50 at St. Deiniols Library, Gladstone Way, Hawarden running in a north-westerly direction for approximately 105 yards from the Cemetery of St. Deiniols Church to a part on Gladstone Way to a line running in a south-westerly direction from such Cemetery as aforesaid for approximately 61 yards then turning and running in a north-westerly direction for approximately 55 yards to a point on Gladstone Way aforesaid then proceeding in a northerly direction along the footpath of Gladstone Way aforesaid.

If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
