#### NORTH YORKSHIRE COUNTY COUNCIL

*North Yorkshire County Council Footpath No. 7 (Part) Settrington Parish Diversion Order 1980 and Footpaths No. 8 (Part) Settrington and No. 3 (Part) Wharram Parish Diversion Order 1980.*

Notice is hereby given that the above-named Orders made on 11th November 1980, are about to be submitted to the Secretary of State for the Environment for confirmation as opposed Orders or to be confirmed as unopposed Orders by the North Yorkshire County Council.

The effect of the footpaths to be diverted will be:

##### 1. Footpath No. 7 (Part) Settrington Parish

###### *Existing Footpath*

The footpath commences on a point on a hard surfaced track (marked A on the deposit map), this point is approximately 70 metres north of the south-western corner of O.S. Field No. 97 and leads in a generally northerly direction along the hard track for approximately 450 metres to the eastern boundary of O.S. Field 82 (marked B on the deposit map).

###### *Proposed Footpath*

The new footpath commences at the above point A and leads north-easterly across the corner of O.S. Field 97 for approximately 40 metres to a point which is situated at the southern end of Screed Plantation (marked C on the deposit map), the footpath then enters the plantation (situated in O.S. Field 96) and leads in a generally north-easterly direction inside the eastern boundary of the plantation for approximately 450 metres where it meets an existing track which leads to Wold Barn (marked D on the deposit map) the footpath then turns westerly to run along the existing track through the centre of the plantation for approximately 70 metres whence it joins the existing footpath at the above point B.

##### 2. Footpath No. 3 (Part) Wharram + No. 8 (Part) Settrington Parish

###### *Existing Footpath*

The footpath commences on a hard surfaced track (marked A on the deposit map) and leads northwards along O.S. Field 8A to the south-east corner of O.S. Field No. 3, the path then continues northwards along the eastern boundary this field for approximately 200 metres then veers north-westerly to Whitestone Beck (marked B on the deposit map) from this point the footpath runs within the eastern boundary of Wood House Plantation which is in O.S. Field No. 113 for approxi-

mately 80 metres (to point C on the deposit map) from which it runs along the southern boundary of O.S. Field No. 83, the northern boundary of O.S. Field 108 and the southern boundary of O.S. Field No. 111 for 350 metres where the path ends (marked D on the deposit map).

###### *Proposed Footpath*

The new footpath commences at the above point A and leaves the hard surfaced track to run inside the eastern boundary of O.S. Field No. 9 for approximately 65 metres to point E (marked on the deposit map) which is situated in the north-east corner of Field O.S. No. 9 after which the new footpath follows the northern boundary of the said O.S. Field No. 9 in a westerly direction for approximately 270 metres to point F (marked on the deposit map) which is situated on the northern boundary of Field O.S. No. 9 and from this point crosses into O.S. Field No. 4 the footpath then leads along the southern boundary of this field for approximately 116 metres to point G (marked on the deposit map) after which it veers north-westerly through this field and follows a depression down the dale to cross Whitestone Beck at point H (marked on the deposit map) a further distance of 260 metres from this point the footpath continues north-westerly across O.S. Field No. 5 for approximately 190 metres to point I (marked on the deposit map) where it joins the hard surfaced access road to Settrington Wood House. The footpath then follows the farm road northerly and easterly to re-join the original footpath at point D (marked on the deposit map) just east of Settrington Wood House the distance of this section being approximately 560 metres. Whitestones Beck as indicated H is the Settrington and Wharram Parish boundary, the Birdsall and Settrington Estate Boundary is also the merging point of footpaths Wharram 3 and Settrington 8.

Copies of the Orders and maps contained in them have been deposited at the North Yorkshire County Council Divisional Highways Office, Westgate, Old Malton, Malton, and may be inspected free of charge during normal office hours.

If you wish to have sent to you in due course a notice to the effect that the Orders have been confirmed and copies of the Orders as confirmed, you should write to the Chief Executive, North Yorkshire County Council, County Hall, Northallerton, giving your name and the address to which the documents may be sent.

Any representations or objections with respect to the Orders may be sent to the Chief Executive at the above address before 29th December 1980 and should state the grounds on which they are made.

If no representations or objections are duly made, or if any so made are withdrawn, the North Yorkshire County Council may, instead of submitting the Orders to the Secretary of State, themselves confirm the Orders. If the Orders are sent to the Secretary of State, any representations or objections which have been duly made and not withdrawn will be submitted with the Orders.
