The Order will contain the usual exemptions including the The Order will contain the usual exemptions including the right for passengers to board or alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties and to enable a vehicle to take in petrol, oil or air from any garage situated adjacent to the restricted lengths of sides of road.

In addition the Order will contain the usual parking concessions for disabled persons in accordance with the

Orange Badge Scheme.
