**ROCHDALE BOROUGH COUNCIL**

**CLEAN AIR ACT 1956**

*The Rochdale Borough Council (Middleton Central No. 16  
Smoke Control Order 1968) Variation Order 1981*

Notice is hereby given that the Rochdale Borough Council in exercise of the power conferred on them by section 11 of the above-mentioned Act on 13th January 1981 made an Order entitled the Rochdale Borough Council (Middleton Central No. 16 Smoke Control Order 1968) Variation Order 1981, declaring the area described in the Schedule hereto to be no longer exempt from the operation of section 11 of the Clean Air Act 1956.

Subject to the exemptions provided by virtue of section 11 (2) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Copies of the Order may be inspected free of charge at the Secretary's Department, Town Hall, Rochdale and also at the Information Office, London House, Oldham Road, Middleton, Greater Manchester at all reasonable times during the period of 6 weeks from 23rd January 1981.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary of State, Department of the Environment, Becket House, Lambeth Palace Road, London SE1 7ER object to the confirmation of the Order.
