also bounded by but not including Barnhurst Lane from its junction with Pendeford Mill Lane to the County Boundary and by the County Boundary from Barnhurst Lane to Codsall Road, and bounded by but not including Codsall Road from the

County Boundary, Birches Road and Wolverhampton Road to its junction with Elliotts Lane.
