Notice is hereby given that Her Majesty was pleased on the 18th March 1981, by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. (1) Dissolving the benefice of Ruswarp with Sneaton ;
- (2) transferring the parish of Ruswarp to the benefice of Aislaby, and
- (3) transferring the parish of Sneaton to the benefice of Eskdaleside with Uglebarnby, in the diocese of York.
