HIGHWAYS ACT 1980

The Cardiff-Llangurig Trunk Road A470 (Coryton Interchange Side Roads) Order 198

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road at Coryton in the County of South Glamorgan to make under section 14 of the Highways Act 1980, an Order which will:

(a) authorise him:

(i) to stop up the exit road including the verges from the Forest Farm Industrial Estate Access Road.

(ii) to construct a new highway to connect the Forest Farm Industrial Estate access road with the Trunk Road,

all at Coryton in the County aforesaid and

(b) provide for the transfer of the said new highway to the County Council of South Glamorgan as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.
